Coming together was joyous, whatever the occasion.

The value of our human connections is beyond measure, and researchers studying isolation among aging adults and people with disabilities know the painful cost of losing social ties.

Loneliness and social isolation are more hazardous to health than obesity and comparable to smoking nearly a pack of cigarettes a day, according to U.S. Surgeon General Vivek Murthy. Illness traced to loneliness costs Medicare billions annually, but there's a simple remedy—human contact.

This is the lifeline you provide with your support of Guardianship Services, Inc., whether through our core services or new programs approved for funding in 2022.

The Lifeline Friendly Visitor pilot program is just one example. Made possible by American Rescue Plan Act (ARPA) funds administered by Tarrant County, it matches isolated, aging adults with older volunteers to ease the loneliness of both.

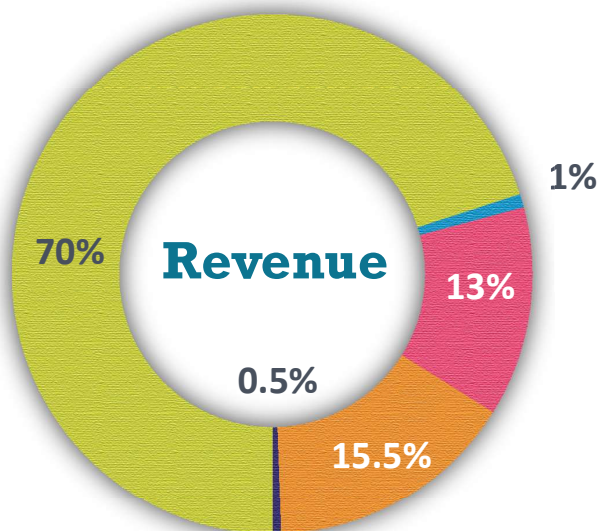

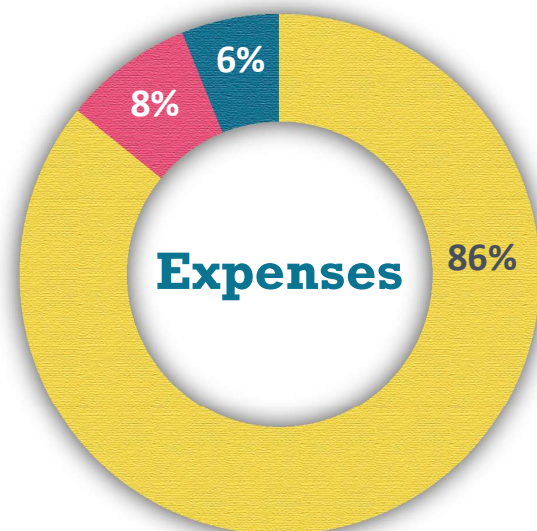
