**GUARDIANSHIP PROGRAM:** Our Guardianship program provides 24-hour, on-call services for adults living with cognitive, intellectual or developmental disabilities.

**MONEY MANAGEMENT:** Money Management services are flexible alternatives to guardianship. These voluntary programs safeguard financial stability and prevent financial exploitation.

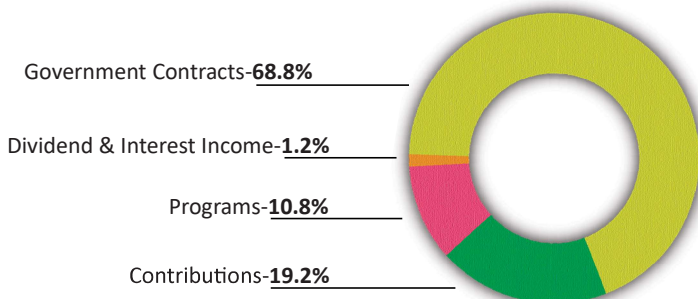
**FINANCIAL EXPLOITATION PREVENTION CENTER:** Our Financial Exploitation Prevention Center unites GSI with the Tarrant County Criminal District Attorney, community agencies, and social service partners to prevent and prosecute fraud or financial exploitation of vulnerable adults. **LIFELINE PROGRAM:** Our Lifeline Program is easing an epidemic of loneliness among homebound and isolated seniors. The Lifeline Community Services Navigator connects seniors to needed programs, benefits and services, thanks to American Rescue Plan Act dollars administered by Tarrant County.

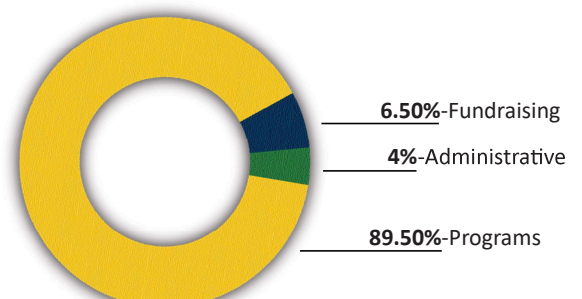
**E<sup>3</sup>: EDUCATE, ENGAGE, ENROLL:** The E<sup>3</sup> program helps struggling seniors save by enrolling in Medicare Savings Programs. Eligible seniors can save thousands of dollars a year, and GSI is here to help them navigate the application process from start to finish.

**AMERICORPS SENIORS:** AmeriCorps Seniors volunteers ages 55 and older are fighting fraud and financial exploitation of our elders as peer fraud prevention and financial literacy coaches. Their mission: extending the reach of Financial Exploitation Prevention Center public education.

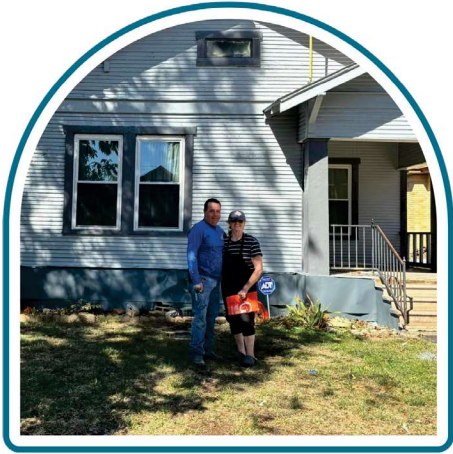
## 2023 Revenue

Thanks to the Financial Exploitation Prevention Center at GSI, volunteers painted this southside home after a contractor abandoned the job and aging homeowner. She is one of 1,672 people served by the FEPC in the year ending September 30.

A gifted educator, Frank slipped under dementia's spell, then fell prey to exploitation. Our Guardianship program protects 264 at-risk adults like Frank with 24-hour, on-call services by Texas certified guardians.

Yolanda and her daughter were homeless but found their way in our Money Management program. It served 235 at-risk adults in the year ending September 30 and protects more than \$3 million in income from misuse annually.
